

# BYLAW NO. 09 – 2021 TOWN OF VEGREVILLE

THIS BYLAW NO. 09-2021 OF THE TOWN OF VEGREVILLE, IN THE PROVINCE OF ALBERTA TO ESTABLISH AN INTER-MUNICIPAL COMMITTEE

**WHEREAS** Section 145 of the *Municipal Government Act*, RSA 2000, Chapter M-26, provides that a Council may establish, by bylaw, committees of Council and to define their functions,

AND WHEREAS Council wishes to establish an Inter-Municipal Committee to enhance the working relationship between the County of Minburn No. 27 and the Town of Vegreville,

NOW THEREFORE, the Council of the Town of Vegreville, duly assembled enacts as follows:

## 1. SHORT TITLE

1.1 This Bylaw may be cited as the Inter-Municipal Committee Bylaw.

#### 2. **DEFINITIONS**

- 2.1 Council means the duly elected Council of the Town of Vegreville.
- 2.2 County means the County of Minburn No. 27.
- 2.3 **Town** is the municipal corporation of the Town of Vegreville.

## 3. PURPOSE

- 3.1 The purpose is of this Committee is to establish meaningful and ongoing intermunicipal communication with the County to:
  - (a) Establish effective collaboration between the Town and County
  - (b) Ensure routine monitoring of inter-municipal relationships and agreements
  - (c) Provide a forum to deal with inter-municipal concerns and regional opportunities in a mutually beneficial and timely fashion
  - (d) Provide advice and recommendations to Council regarding inter-municipal issues

  - (a) Mayor
  - (b) Town Councillor
  - (c) Town Councillor
  - (d) Alternate Town Councillor

5.1 Quorum will be two (2) members of Council with the Town Manager or designate

8.1 This Bylaw shall come into effect upon the date of the passing of third reading.
