# BYLAW NO. 8-00 TOWN OF VEGREVILLE

THIS BYLAW BEING BYLAW NO. 8-00 OF THE TOWN OF VEGREVILLE, IN THE PROVINCE OF ALBERTA FOR THE PURPOSE OF PROVIDING SPECIFIED NON-PROFIT COMMUNITY ORGANIZATIONS WITH AN EXEMPTION FROM MUNICIPAL TAXATION

WHEREAS

Pursuant to Sections 364(1) of the Municipal Government Act, Statutes of Alberta 1994, Chapter M-26.1, and the Community Organization Property Tax Exemption Regulation, AR 281/98, Council may pass a bylaw exempting from municipal taxation specified non-profit community organizations.

NOW THEREFORE, BE IT RESOLVED THAT THE COUNCIL OF THE TOWN OF VEGREVILLE IN THE PROVINCE OF ALBERTA DULY ASSEMBLED ENACTS AS FOLLOWS:

#### 1. NAME

This Bylaw may be cited as the "Non-Profit Community Organizations Exemption Bylaw."

#### 2. **DEFINITIONS**

- 2.1 "Assessor" means the person appointed as Assessor in Bylaw 15-99.
- 2.2 "Council" means the Council of the Town of Vegreville.

### 3. EXEMPTION FROM MUNICIPAL TAXES

- 3.1 The property or portions of the property occupied by the non-profit community organizations listed in Schedule A are hereby exempted from municipal taxation, if the organization:
  - a) submits an annual application to the CAO for exemption, and;
  - b) continues to meet the required criteria.

### 4. NUMBER AND GENDER REFERENCES

4.1 All references in this bylaw shall be read with such changes in number and gender as may be appropriate according to whether the reference is to a male or female person, or a corporation or partnership.

## 5. ADDING QUALIFYING ORGANIZATIONS

5.1 Town Council may by resolution add non-profit community organizations to Schedule A.

## 6. EFFECTIVE DATE

THIS Bylaw shall take effect on the day of the final passing thereof.
