



## BYLAW NO. 19-2018

# TOWN OF VEGREVILLE

**THIS BYLAW NO. 19-2018 OF THE TOWN OF VEGREVILLE, IN THE PROVINCE OF ALBERTA FOR THE PURPOSE OF ESTABLISHING THE LAND USE COMMITTEE FOR THE TOWN OF VEGREVILLE**

**WHEREAS** Section 145 of the Municipal Government Act, RSA 2000, c-M26 provides that Council may pass bylaws to establish council committees and to define their functions.

**AND WHEREAS** Council wishes to establish a Committee known as the Land use Committee to advise Council on matters relating to Land Use Planning.

**NOW THEREFORE** the Council of the Town of Vegreville in the Province of Alberta, enacts as follows:

### 1. TITLE

1.1 This Bylaw may be cited as the **Land Use Committee Bylaw**.

### 2. DEFINITIONS

2.1 **Committee** means the Land Use Committee;

2.2 **Council** means the elected governing body of the Town of Vegreville;

2.3 **Councillor** means an elected official for any municipality, either urban, rural or specialty, in the Province of Alberta.

### 3. ESTABLISHMENT

3.1 The Land Use Committee is established as a Committee of Council under this Bylaw.

### 4. MANDATE

4.1 The mandate of this Committee is to provide advice and recommendations to Council regarding the Land Use Bylaw and the Municipal Development Plan

### 5. MEMBERS

5.1 The Committee will consist of seven (7) members and three (3) alternate members, which will be led by an elected chair:

5.2 Voting Members:

(a) Mayor

(b) Two (2) members of Council

(c) One (1) Alternate member of Council

(d) Two (2) members-at-large – representing business

(e) Two (2) members-at-large – representing residents

(f) One (1) Alternate member-at-large - representing business

(g) One (1) Alternate member-at-large - representing residents

5.3 Support Staff:

- (a) Planning & Development Staff

6. QUORUM

- 6.1 Will be a simple majority of voting members

7. TERM

- 7.1 Members of the Land Use Committee should commit to involvement of a minimum of one year.

8. MEETINGS

- 8.1 Meetings will be held on an "as required" basis at the call of the Chair.

9. EFFECTIVE DATE OF BYLAW

- 9.1 This Bylaw shall come into effect upon third and final reading
