

## BYLAW NO. 12–2019 TOWN OF VEGREVILLE

THIS BYLAW NO. 12-2019 OF THE TOWN OF VEGREVILLE, IN THE PROVINCE OF ALBERTA TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE TOWN OF VEGREVILLE FOR THE 2019 TAXATION YEAR.

**WHEREAS** the Town of Vegreville has prepared and adopted detailed estimates of the municipal revenues and expenditures as required, at the Council meeting held on December 10, 2018; and

**WHEREAS** the estimated municipal expenditures and transfers set out in the budget for the Town of Vegreville for 2019 total \$21,043,018 and

WHEREAS the estimated municipal revenues and transfers from all sources other than taxation is estimated at \$11,732,204 and the balance of \$9,310,814 is to be raised by general municipal taxation; and
