#2017-FEB-25 ARNOLD VIERSEN, MP PEACE RIVER-WESTLOCK – LETTER TO MAYOR MYRON HAYDUK

Correspondence dated February 13, 2017 from Arnold Viersen, MP, Peace River-Westlock stating:

Thank you for your letter regarding the Case Processing Centre (CPC) in Vegreville. I completely agree with you that the Immigration, Refugees and Citizenship Canada (IRCC) office should remain in Vegreville. There is no need to move the CPC to Edmonton; IRCC has operated efficiently out of Vegreville for decades.

Alberta is already suffering from low oil and gas prices and resultant job losses. Rural sustainability is an issue that is more important than ever. Consideration must be given to the impact the CPC move will have on its employees, their families, and the town that depends on the CPC as a major employer and significant contributor to the local economy.

Conservatives fully support the fight to keep the CPC in Vegreville. We will continue to push the Liberal Immigration Minister to reverse this decision.

Correspondence dated February 8, 2017 from Christina Gray, Minister of Labour to The Honourable Ahmed Hussen, Minister of Immigration, Refugees and Citizenship Canada stating:

I am writing to you today on behalf of the Government of Alberta to express my concern over the Government of Canada's decision to relocate the Immigration, Refugees and Citizenship Canada's Case Processing Centre (CPC) from Vegreville, Alberta to a new location in Edmonton, Alberta by the end of 2018. I previously wrote to former Minister John McCallum voicing my concern over this matter on October 31, 2016.

I understand the decision to relocate the CPC is intended to improve efficiency in light of increased demand on Immigration, Refugees and Citizenship Canada's various lines of business. I also understand that ease of access to amenities in Edmonton makes it easier for federal recruitment efforts; however, I am concerned impacts of the closure have not been adequately considered.

The decision to relocate the CPC to Edmonton will have a profound negative impact on workers and their families. The CPC provides 280 jobs in Vegreville and its surrounding areas and is Vegreville's single largest employer. I am concerned not only by the decision to relocate the CPC but by the lack of consultation in the local community. I am also concerned this decision may signal reduced support for rural communities in Alberta and across Canada.

The Mayors of Vegreville and Waskatenau have stated this decision is devastating to their communities. The Public Service Alliance of Canada has also voiced their concern and opposition to the CPC relocation to Edmonton. I am asking you to reconsider your government's decision in light of these concerns. I look forward to your response on this important matter.

I wish to voice my concerns regarding the recent decision to relocate the Immigration, Refugee and Citizenship Case Processing Centre from Vegreville, Alberta.

Since this centre opened in 1994, it has been the Vegreville region's largest employer, providing 280 jobs in a community of 6,000 people. The loss of nearly 5% of the region's jobs will severely impact those who live here, with the effects felt in other sectors of the local economy. Job loss on this scale will come at a high human cost to this rural region's workers and their families.

Since this centre opened, it has also been the Vegreville region's most stable employer. During downturns in the economy, the government service centre provides steady employment, benefitting Vegreville and surrounding communities with greater economic stability. Alberta is currently recovering from a significant economic downturn. Now is not the time to introduce instability to communities still in economic recovery.

I would like to add my concerns to those expressed by many others. I respectfully request that you reconsider your decision to close this centre and that you renew your consultation with the local workers through PSAC (Public Service Alliance of Canada) and the Town of Vegreville.

Congratulation on your new role as the Minister of Immigration, Refugees and Citizenship. Canada has been a beacon of hope for people from all over the world as being a place where you can create a new life for your family and be accepted as part of our diverse community.

It is with my sincere concern for the workers and families of Vegreville that I write to you regarding the recent decision to relocate the Immigration, Refugee and Citizenship Case Processing Centre, currently in Vegreville, to Edmonton.

Public Sector jobs such as those with the Federal government bring economic security, family stability, and local purchasing power. This is especially noticeable during the economic downturn that Alberta is currently, and is acutely felt in rural Alberta.

Correspondence dated February 22, 2017 from Sherie Benson, MP, Saskatoon West & NDP Labour Critic and Jenny Kwan, MP, Vancouver- West & NDP immigration & Citizenship Critic to The Honourable Ahmed D. Hussen, MP, stating:

We write to urge you to reverse your predecessor's decision to close the Vegreville Case Processing Centre.

As you may know, the Vegreville CPC, established in 1994, is the largest and most stable employer in the Town of Vegreville. According to the latest available IRCC Performance Report for 2015-2016, the Vegreville CPC is extremely efficient - operating at 93% of new applications, and 97% of applications for extensions - well above the Department's service standard targets of 80%.

Currently, the Centre employs 236 people, and its closure will have a tremendous impact on the economy, quality of life, and viability of the Town of Vegreville. Apart from the removal of approximately 9% of the town's workforce, local unemployment could also double from 8% to 16%, not to mention the ripple effects of a devastating potential loss of 420 individuals – an erosion of the quality of life of affected families, and the permanent change in community dynamics – everything from fewer students in local schools, to fewer volunteers to serve the community.

Minister, we urge you to reconsider this closure. There has been no consultation with the Town of Vegreville before this announcement was made, and there was no assessment of the economic consequences of closing the community's largest employer. This decision is directly at odds with the federal government's campaign promise to "strengthen our communities by investing in the things that make them good places to live." In fact, the Prime Minister himself has said that "...at the same time there are communities in rural and remote areas across the country who need to continue to, to be able to be successful. So getting that balance right is really, really important. . . [it] simply means a lot more collaboration, cooperation and respect." Maclean's Town Hall, December 16, 2015.

Minister, this decision to close the Vegreville CPC was made with no collaboration, cooperation or respect.

Closing a Centre that is performing well. Eliminating a rural community's largest employer, and devastating the lives of hundreds of families makes no sense.

There are many voices calling for a reversal of this decision, Minister – from across all parties, and from all levels of government. We hope you will listen, and act immediately to halt the closure of the Vegreville CPC.

#2017-FEB-36 PAUL SUITER, RECREATION & FACILITIES MANAGER – LETTER OF SUPPORT FOR VEGREVILLE MINOR SOCCER ASSOCIATION

A Request for Council Decision dated February 27, 2017 from Paul Suiter, Recreation & Facilities Manager, stating:

The V.M.S.A approached the Town of Vegreville in 2016 with a proposal to construct a soccer park which would meet the needs of the organization by having sufficient number of soccer fields in one location. This concept would enable the V.M.S.A. to be in a position to apply and host larger tournaments as well as provincial competition. The V.M.S.A. would also gain some certainty to their operations by relocating the majority of play to a new park under their control.

The V.M.S.A. investigated possible locations and scenarios for what would be available, for the development of a soccer park. The parcel of land known as Block A Plan 762 0421 is owned by the Town of Vegreville and currently is leased for farm purposes. This parcel of land that would be available is totaling 112 acres. The V.M.S.A. is requiring approximately 35 acres of that parcel. The Town of Vegreville is agreeable in principal to the concept and to enter a lease for the required land to the V.M.S.A.

The V.M.S.A. requires a letter of support indicating the Town of Vegreville will enter a lease for the land for this purpose in order that the association may apply for grants for the funding for the project.

The parcel of land currently leased for farm use so there would be an amendment to that lease which would result in a minor financial implication as it is currently in the final year of the agreement.

Councillor Berry moved that Town Council direct Administration to prepare and provide a letter of support to the V.M.S.A. detailing that the Town of Vegreville agrees to lease a parcel of Town owned land for a 20 year term with a 5 year renewal option to the V.M.S.A for the purpose of the construction of a soccer park.

#2017-FEB-38 DALE LEFEBVRE, INFRASTRUCTURE, PLANNING & DEVELOPMENT DIRECTOR – CAPITAL BUDGET PURCHASE OF GARBAGE TRUCKS

A Request for Council Decision dated February 22, 2017 from Dale Lefebvre, Infrastructure, Planning & Development Director stating:

At the February 21, 2017 Legislative Committee Meeting, Council was given information about the status of two Town of Vegreville garbage truck units and a proposal to purchase two garbage trucks from the Town of Vermilion to replace them.

The Town of Vermilion has agreed to sell their 2010 and 2016 Peterbilt PB 320 garbage trucks and \$30,000 in replacement rams and cylinders to the Town of Vegreville for \$310,000. The Parks & Fleet Manager and the Head Mechanic have been to Vermilion to inspect these trucks and have deemed both trucks suitable and mechanically sound.

Upon approval, the Infrastructure, Planning & Development Department will reduce the expense amount proposed in the 2017 Capital Budget from \$355,000 for one new truck to \$310,000 for the two Town of Vermilion trucks.

The Town of Vegreville, with Council's approval, will purchase the trucks utilizing Reserve Operating Account# 4-671-00-00-00 prior to the 2017 Budget approval.

Councillor MacPhee moved that Town Council approve the purchase of two garbage trucks, including replacement parts, from the Town of Vermilion at a maximum of \$310,000; and

Further that Town Council approve utilizing funds in Reserve Operating Account# 4-671-00-00-00 to complete the purchase prior to 2017 Budget approval.

#2017-FEB-39 DALE LEFEBVRE, INFRASTRUCTURE, PLANNING & DEVELOPMENT DIRECTOR – STREET LIGHT REPLACEMENT ON MAIN STREET

A Request for Council Decision dated February 22, 2017 from Dale Lefebvre, Infrastructure, Planning & Development Director stating:

On February 8, 2017, information regarding the deterioration of the decorative street lighting on Main Street and the replacement costs from ATCO was presented to Council at the Legislative Committee Meeting. The consensus of those present was that the project should go ahead in 2017.

ATCO Electric has supplied a Proposal for Electric Service outlining the Town's contribution amount and the terms of service. The Town will be responsible for providing a purchase order number, signing and returning a copy of the proposal, coordinating traffic control while crews are working, and replacement of the paving stones if required. ATCO Electric will supply the 22 LED 88 watt decorative lights, including poles, plug-ins, banner and flower pot arms and all other associated hardware. As well, ATCO will ensure that all easements and external approvals are obtained. ATCO will retain ownership of the lights and will be responsible for the maintenance of them.

The Town's contribution amount is estimated at \$23,958 plus GST. This is an estimate only and, upon completion of the installation, the Town will be invoiced the actual cost once reconciled.

The Infrastructure, Planning & Development Department has included the amount of \$30,000 in the 2017 Operating Budget to account for the expense.

Councillor Berry moved that Town Council approve Administration signing the Proposal for Electrical Service from ATCO Electric for the replacement of 22 decorative street lights on Main Street.
