**Canada Alberta Job Grant** – Deadlines for current approved grants are extended by 3 months. Training can start within 9 months of grant approval and must be completed within 15 months of the training start date. If a course is postponed, contact the CAJG to update your file. If a course is cancelled, contact CAJG to withdraw. If you plan to re-apply for a course at a later date, get a refund from the provider or institution, not a credit. Grant applications and training completion forms may take longer to process. ## Federal Programs

**Canada Emergency Response Benefit (CERB)** – a reminder that you have to apply for this every month and not just once to get four payments. \$2000/month for up to four months for those that have lost their income due to COVID-19. Update as of Friday is that you can now earn up to \$1000 per month and still qualify. ### New Federal Programs

**Canada Emergency Wage Subsidy:** To help businesses keep and return workers to their payroll through the challenges posed by the COVID-19 pandemic, the government approved the Canada Emergency Wage Subsidy. This would provide a 75% wage subsidy to eligible employers for up to 12 weeks, retroactive to March 15, 2020. The program provides up to \$847 per week per employee between March 15 and June 6. Eligible employers will also receive a 100% refund for certain employer-paid contributions to EI. **The program will launch of April 27, 2020. **Community Futures funding** - the Prime Minister made an announcement on Friday April 17th that allocates \$287M in funding to the Community Futures Program. This funding will be allocated towards smaller employers and businesses located in rural parts of the country who do not qualify for the recently announced wage subsidy or loans or who still need assistance in managing their operations through these challenging times. **Canada Summer Jobs – If you had a successful application in for this program, there are changes to help ensure you are still able to take advantage of the program. Changes include:** an increase to the wage subsidy, so that private and public sector employers can also receive up to 100 per cent of the provincial or territorial minimum hourly wage for each employee; an extension to the end date for employment to February 28, 2021; allowing employers to adapt their projects and job activities to support essential services; allowing employers to hire staff on a part-time basis. **The Canada Emergency Business Account (CEBA)** will provide interest-free loans of up to \$40,000 to small businesses and not-for-profits, to help cover their operating costs during a period where their revenues have been temporarily reduced. To qualify, these organizations will need to demonstrate they paid between \$20,000 to \$1.5 million in total payroll in 2019. Repayment time frame would be to December 3, 2022. Business owners can apply for support from the Canada Emergency Business Account through their banks and credit unions.

**Canada Emergency Commercial Rent Assistance (CERCA)** to provide loans to commercial property owners, who in turn will lower or forgo rent of small businesses in April, May and June. Implementation of the program will require a partnership with provincial and territorial governments who are responsible for property owner-tenant relationships. Employer Contact Centre: 1-800-367-5693. **Extending Work-Sharing program:** *The Government of Canada is Implementing the EI Work Sharing Program, which provides EI benefits to workers who agree to reduce their normal working hour as a result of developments beyond the control of their employers, by extending the eligibility of such agreements to 76 weeks, easing eligibility requirements, and streamlining the application process. This was announced by the Prime Minister on March 11, 2020.)*
